

AFFILIATE PROGRAM TERMS & CONDITIONS

Last Updated: February 17, 2026

1. OVERVIEW

This Affiliate Program Agreement ("Agreement") contains the complete terms and conditions that apply to your participation in the **PairTrading.Pro** Affiliate Program (the "Program").

By submitting an application or promoting our products, you warrant that you have read and understood this Agreement and agree to be bound by its terms.

2. ENROLLMENT & ELIGIBILITY

2.1. Application. To begin, you must submit a completed Affiliate Program application via our website.

2.2. Approval. We reserve the right to reject or suspend any application at our sole discretion.

- **Suitable Affiliates:** We welcome trading education blogs, YouTube channels, cryptocurrency news websites, financial software review sites, and active trading communities/Discords.
- **Prohibited Sites:** We will strictly reject applications from sites promoting violence, hate speech, illegal activities, Ponzi schemes, HYIPs, "get rich quick" scams, adult content, or sites providing unlicensed financial advice with profit guarantees.

3. COMMISSIONS AND PAYMENTS

3.1. Commission Structure

You will receive a **30% recurring commission** (or as otherwise specified in your dashboard) on all net sales generated through your unique referral link.

- **"Net Sales"** means the amount actually received by us from the customer, excluding any transaction fees, taxes, or subsequent refunds.
- **Lifetime Revenue Share:** You continue to earn commission as long as the referred customer maintains an active, paid subscription.

3.2. Cookie Duration

We use a **60-day cookie duration**. If a user clicks your link and subscribes within this period (even if they close the browser and return later directly), you will be credited with the referral.

3.3. Hold Period (Anti-Fraud)

To ensure the validity of payments and account for our Money-Back Guarantee, all commissions have a **30-day maturity period**.

- *Example:* If a sale occurs on January 1st, the commission is "Locked" until January 30th. If the customer does not request a refund during this time, the commission becomes "Available for Payout."

3.4. Payout Schedule

- **Minimum Threshold:** Payouts are processed once your *Available Balance* reaches **50 USDT**.
- **Frequency:** Payouts are made monthly, typically by the **15th** of the following month.
- **Method:** All payouts are made exclusively in **USDT (Tether)** via the **TRC-20 (Tron)** or **BEP-20 (BNB Chain)** networks.
- **Fees:** Network transaction fees (Gas) for payouts are deducted from your withdrawal amount. Please ensure your wallet address is correct; lost funds cannot be recovered.

3.5. Refunds and Chargebacks (Clawback Policy)

If a referred customer requests a refund (in accordance with our Refund Policy) or issues a chargeback, the corresponding commission will be deducted from your balance. If the commission has already been paid out, the amount will be deducted from your *future* earnings.

4. PROHIBITED ACTIVITIES (STRICT)

To protect the integrity of the Program, the following activities are strictly prohibited.

Violation will result in **immediate ban and forfeiture of all earnings**:

1. **Self-Referrals:** You **cannot** refer yourself. Creating a second account to purchase a subscription via your own affiliate link to get a discount is prohibited.
2. **Brand Bidding (PPC):** You are prohibited from bidding on keywords containing "Pair Trading Pro", "PairTradingPro", or misspellings thereof in Pay-Per-Click campaigns (Google Ads, Bing, etc.). You must add our brand name as a "negative keyword."
3. **Spamming:** Sending unsolicited emails (spam), mass telegram DMs, or forum spam is forbidden.
4. **Misleading Claims (Compliance):** You **MAY NOT** make guarantees of profit (e.g., "Guaranteed 100% ROI", "Risk-Free Money") or provide financial advice when promoting our tool. You must include a standard risk disclaimer in your promotional materials.
5. **Cookie Stuffing:** Use of invisible iframes, scripts, or automated bots to set cookies without a user's conscious click is prohibited.
6. **Deceptive Sites:** You may not create websites that copy the look and feel of our official website ("Phishing" or "Spoofing").
7. **Incentivized Traffic:** Offering cashback, rebates, or sharing your commission with referred users to incentivize signups is prohibited unless explicitly approved in writing.

8. **Trademark Misuse:** Registering domain names containing "PairTradingPro" or similar variations is prohibited.

5. MARKETING MATERIALS

We grant you a non-exclusive, non-transferable license to use the logos, banners, and marketing materials provided in your Affiliate Dashboard solely for the purpose of promoting the Service. You may not modify these materials in a way that alters the brand image without our prior written consent.

6. RELATIONSHIP WITH REFERRED CUSTOMERS

6.1. No Direct Contact Required. You are not responsible for providing customer support to users you refer. All support is handled by PairTrading.Pro.

6.2. No Access to Customer Data. You will not receive personal information about your referrals beyond what is shown in your Affiliate Dashboard (e.g., subscription status, commission amount).

6.3. Customer Ownership. All customers referred by you remain customers of PairTrading.Pro. You have no ownership rights or claims to these customer relationships beyond your commission rights.

7. INDEPENDENT CONTRACTOR

You are an independent contractor. Nothing in this Agreement creates any partnership, joint venture, agency, franchise, or employment relationship between you and PairTrading.Pro. You have no authority to make or accept any offers or representations on our behalf.

8. CONFIDENTIALITY

You agree to keep confidential:

- Your specific commission rates (if custom/negotiated).
- Any non-public information about our conversion rates or metrics.
- Internal communications with our affiliate team.

You may publicly disclose that you are a PairTrading.Pro affiliate.

9. MODIFICATIONS TO PROGRAM

9.1. Commission Changes. We reserve the right to modify commission rates, cookie duration, or payout terms at any time. Changes will be communicated via email at least 14 days before taking effect.

9.2. Existing Referrals. Commission rate changes apply to NEW referrals only. Existing referred customers will continue at the rate in effect at the time of their original signup (Grandfathering).

9.3. Program Discontinuation. We may discontinue the Affiliate Program entirely with 30 days' notice. In such case, all Available Balances will be paid out.

10. TAXES

You are solely responsible for reporting and paying any applicable taxes or duties on the

commissions you receive in your jurisdiction. Since we pay in cryptocurrency, we do not withhold taxes unless explicitly required by law.

11. TERMINATION

We may terminate your participation in the Program at any time, with or without cause, by giving you written notice via email.

- **For Cause:** If terminated for violation of Section 4 (Fraud/Prohibited Activities), all pending and future commissions will be forfeited.
- **Without Cause:** If we terminate the program generally, we will pay out any outstanding *Available Balance* regardless of the minimum threshold.

12. DISPUTE RESOLUTION

12.1. Tracking Disputes. If you believe a referral was not properly tracked, you must notify us within 30 days of the alleged referral date with supporting evidence.

12.2. Commission Disputes. Disputes regarding commission calculations must be raised within 14 days of the commission appearing in your dashboard.

12.3. Final Decision. Our records and tracking systems are the definitive source for all referral and commission data. Our decision on disputes is final.

13. LIMITATION OF LIABILITY

We will not be liable for indirect, special, or consequential damages (or any loss of revenue, profits, or data) arising in connection with this Agreement or the Program, even if we have been advised of the possibility of such damages.

14. GOVERNING LAW

This Agreement shall be governed by and construed in accordance with the laws of **England and Wales**, consistent with our main Terms of Service.
